#### 272/22-23 DECEMBER 2022 TOWN COUNCIL MEETING MINUTES

## 273/22-23 PUBLIC PARTICIPATION

#### (a) Police Report

PCSO Palfrey provided the following report for the period 24<sup>th</sup> December 2022 to 23<sup>rd</sup> January 2023:

#### Anti-Social Behaviour – 10 reports:

4 x Noble Close – youths knocking on the door, being loud and disruptive

4 x Shopping Centre – youths causing a nuisance

1 x Licensing Query

1 x Forbes Close – reports of an uninsured vehicle, blocking caller's driveway

**Burglary – dwelling** 0 reports

Burglary - other 0 reports

Vehicle Crime / Offences – 1 report - Birchwood Boulevard – parts of a vehicle stolen

## Criminal Damage – 7 reports:

1 x Redshank Lane – window smashed

1 x Birchwood Forest Park – quad bike across football pitches

1 x Noble Close – electricity cupboard outdoors has been tampered with

1 x Birchwood Shopping Centre – damage in the toilets, unsure who has done this

1 x Layton Close – vehicle damage

1 x Behind Turf & Feather – people stating they are tree surgeons but are not

1 x Chaffinch Close – ongoing issues with neighbours causing damage.

PCSO Palfrey informed Members about a Crime Prevention Scheme called Business Watch which the majority of stores in Birchwood Shopping Centre have now signed up to. He is optimistic that this will substantially reduce incidents of ASB and added that the onus is on the businesses to work together with support from the Police.

He also talked about the ongoing matter of cars parking on Lords Lane and reports of illegal parking. PCSO Palfrey outlined the position of the Police in this regard and said that he would be talking to the Traffic Police to get some further advice.

Councillor Ellis commented that the problems continue as some vehicles park in such a way that it makes it very difficult for mobility scooters and people with prams to pass on the pavement and at certain times of the day there are tailbacks on the main carriageway as vehicles cannot pass each other.

Councillor Allen raised the matter of youths gathering at Birchwood Railway Station and stated that in recent weeks there had been obvious evidence of drug use. He was particularly concerned as this was at around 5 pm when a lot of people use the station.

PC Goodwin reassured Councillors that the area is still receiving attention.

Councillor Scott enquired about the crime statistics for Hamnett Court as a recent press article had stated that 'According to data released by Police.uk, Hamnett Court in Birchwood is responsible for reporting a high percentage of crimes in the area each month.'

PCSO Palfrey was surprised at the report as he was not aware of any particular issues in that area of Birchwood.

PC Goodwin added that it might depend on the timeframe that has been used for the report.

PCSO Palfrey stated that the Police are also involved with a dispute involving neighbouring properties on Chaffinch Close.

A discussion then took place regarding the parking of vehicles in a 'blue badge space'.

Councillor Ellis enquired about the report of an electricity cupboard being tampered with as noted in the Police Report.

PCSO Palfrey stated that there was no evidence of it having been tampered with, but added that there are problems with youths in that area at present resulting in the area having a high Police presence.

#### 274/22-23 WARRINGTON BOROUGH COUNCIL (WBC)

#### Communication

The Clerk informed Members that she had emailed a Borough Council Officer directly regarding progress on a number of outstanding issues, to which she had since received a reply.

#### (a) Evening walkabout/ street lighting

The Clerk enquired if Councillors had any particular dates in mind for the evening walkabout to take place, together with preferred location(s).

After some discussion the 9<sup>th</sup> February was proposed by Members with Chatfield Drive, Fieldfare, Whinchat and behind the Oakwood Shops being highlighted as potential areas.

Councillor Allen said that the route from Locking Stumps shop over the walkway and past the Walled Garden, behind Birchwood High School is very dark and intimidating and enquired if this could also be raised as an area of concern.

Councillor Ellis asked Members to notify the Clerk's office regarding potential locations for additional walkabouts.

**Action** Clerk's office to contact WBC regarding dates and locations for the evening walkabout(s).

#### (b) Powell Avenue/Temporary Ramp

The Clerk informed Members that WBC had queried if the ramp on Powell Avenue, which is damaged, is necessary.

She added that she had informed the Borough Council Officer that without it those with prams or on mobility scooters would struggle to get around the concrete bollards.

The Borough Council Officer replied stating that it might be necessary to remove the ramps but increase the distance between the concrete bollards to allow access for prams and mobility scooters.

#### (c) Admirals Square (Oakwood Local Shops)

The Clerk stated that she had been informed that the queries relating to Admirals Square have been allocated to a WBC Highways Inspector.

Councillor Sheridan commented that Morrisons have now taken over ownership of the shop at Oakwood Mount and the lighting at the front of the shops was much improved as was the general housekeeping, but the paving and car park surface remain very uneven in places.

(d) Armstrong Close and Ainscough Road (potential adoption of street lighting)
The Clerk said that she has been informed that WBC will review the situation over the next few months and will advise once this review has been completed.

A monthly report had been received from Warrington Borough Council just prior to the meeting regarding some other outstanding issues.

- Work throughout borough such as facing off plantings surrounding verges and weeds. Two pieces of work live to be completed in due course, pending ground conditions. **Live**
- Flooded Subway at Lowes Farm Water main burst, work completed. Closed

**Action** Clerk's office to continue to liaise with WBC regarding outstanding issues.

#### **Parish Council Liaison Meeting**

The Clerk reported that she had attended an online Parish Council Liaison Meeting on Thursday, 18<sup>th</sup> January 2023 and gave a brief overview of the items discussed.

She added that one significant item will be the introduction of Voter ID which will require voters to show photo ID at polling stations before a ballot paper is issued. This is expected to be in place for elections from May 2023.

The Clerk confirmed that Officers had started to raise awareness of this change via social media.

#### 275/22-23 YOUR HOUSING GROUP (YHG) – UPDATE

The Clerk stated that she has emailed the Property Agents to enquire about some dates for estate walkabouts and is currently awaiting a response.

It had been suggested that the following streets: Miles, Lyster, Rawlings, Whinchat and Whitethroat Walk areas should be covered this time but other areas will be covered in future walkabouts.

**Action** Clerk's office to continue to liaise with YHG regarding the next walkabout(s).

#### 276/22-23 INFORMATION REGARDING TRAVELLER ENCAMPMENTS

The Clerk informed Members that the two informative documents; a briefing note regarding Police powers, together with a document entitled 'Gypsies and Travellers – A Cultural Awareness Guide' had been posted on the Town Council's website. In addition, an enquiry had been submitted to the Cheshire and Warrington Traveller Team about awareness training for Councillors.

Previously Councillors Brereton, Dempsey, Sheridan and Simcock had expressed an interest in attending.

**Action** Clerk's office to continue to liaise with the Cheshire and Warrington Traveller Team about awareness training for Councillors.

#### 277/22-23 PLANNING UPDATE

Planning Application 2021/40696 – Trident Business Park – Proposed demolition of existing premises and redevelopment of site.

Since the public meeting held in November the Clerk's office had sent a letter of objection to Warrington Borough Council. No further information or amended plans have been received by the Town Council.

## NEW ITEMS RAISED UNDER THE CLERK'S REPORT TO THE COUNCIL

#### 278/22-23 WARRINGTON BOROUGH COUNCIL (WBC)

(a) Sent/received – various emails/online reports/telephone calls following queries/contact from residents regarding flytipping, lights not working, broken bollards, children playing on thin ice, etc.

A detailed response had been received from WBC regarding children playing on thin ice.

'Warrington has been working in partnership with the emergency services and schools to communicate the dangers of venturing onto frozen waterbodies to raise awareness and prevent further accident or loss of life. The provision of signage is unlikely to deter those intent on venturing onto ice particularly unsupervised children and the provision of such signage at regular intervals around all of Warrington's waterbodies is infeasible. Cheshire water safety Group (which cover a range of partners across Cheshire and is Fire Service led) will be working on this issue in a coordinated manner in the long term.

The Council has also received requests to break ice on open water courses to prevent Children playing on the surface. This request is beyond the resources available for the Council, and would require repeat and frequent visits as the water refreezes. The Council would not support or condone our staff walking on the ice because of serious Health and Safety concerns.'

(b) Sent/received – emails re: the old footbridge at Birchwood Railway Station. Concerns include it not being registered as a public right of way, offensive graffiti, general cleansing, roof drainage and work that WBC has planned to cleanse and paint the bridge and install mesh to protect glazing from vandalism.

The Clerk informed members that work is scheduled to start towards the end of February to install mesh along the inside face of the glazing on the bridge to protect it from vandalism and damage. In addition, the bridge will be cleaned and painted and further investigation of the roof drainage will be undertaken to address the flooding.

The old footbridge is owned and maintained by WBC, so internally they are working on officially recording it as a public right of way.

- (c) Sent/received emails and telephone calls re: ongoing flooding at Lowes Farm subway. It transpired that this had been caused by a water leak which was subsequently dealt with by United Utilities (UU). BTC cleaned the area once the work had been completed.
- (d) To note that we continue to send the daily playground inspection reports to WBC. If anything particular is noted, this is specifically flagged up to them.
- (e) We were copied into email correspondence between a resident and WBC regarding WBC's garden waste subscriptions for 2023. The resident was frustrated that they had received an automated email when they had already paid for the 2023 subscription.

## 279/22-23 **YOUR HOUSING GROUP**

- (a) Sent/received various emails/reports following queries/contact from residents including issues with flytipping, shrubbery maintenance, damaged fencing, etc.
- (b) To note that the Clerk has been forwarding photographs and information to YHG regarding the significant amount of flytipped waste that is currently being retrieved from YHG land by the BTC team so that they are aware of the scale of the problem.
- (c) To note that we continue to send the daily playground inspection report for The Birches to YHG. If anything particular is noted, this is specifically flagged up to them.
- (d) A resident raised a concern via Councillor Dempsey regarding an issue they were having regarding repairs to a YHG property. The Clerk liaised with YHG regarding this matter.

#### 280/22-23 MISCELLANEOUS CORRESPONDENCE/ISSUES

- (a) Received various emails from Warrington Voluntary Action (WVA).
- (b) Various pieces of information received, or articles noted in the local press that might be relevant for Birchwood residents, have been published/shared on our Facebook page; e.g. dates of motorway closures and free 'Arthritis Events'.
- (c) To note that BTC continues to report abandoned shopping trolleys for collection.

The Clerk informed Members that she had recently had a discussion with the Trolleywise representative who summarised some of the issues they experience when retrieving trolleys as well as outlining the various types of contract that exist for the retrieval of trolleys.

It was noted that people can report abandoned trolleys by using the Trolleywise App. If they send a report whilst they are at the actual location of the abandoned trolley, the App will use geo-location to create a report.

- (d) To note that we have shared information regarding electric vehicles/EV chargers with a local Parish Council which may be looking to replace one of their diesel vehicles with an electric alternative.
- (e) To note the publication of an article in the Warrington Guardian re: crimes in a particular area of Birchwood (see minute 273/22-23)
- (f) Received further complaints re: cars parking illegally on Lords Lane. These have been shared with PCSO Palfrey (see minute 273/22-23)
- (g) Received an update / information sheet re: the Liverpool John Lennon Airspace Change Proposal.

Cllr Dempsey also reported that the Police and Crime Commissioner had said training is available for Road Marshalls, if required, for local events.

The Clerk added that neither the Carnival nor Remembrance Day have parades which take place on public roads.

(d) To note that a Police Surgery will be taking place at Birchwood Shopping Centre on Wednesday, 25th January 2023 between 6 pm and 8 pm.
